## **Tsumura Announces Change of Certified Public Accountant**

Tsumura & Co. (hereinafter, "Tsumura") announces that at the extraordinary meeting of the Board of Directors held on May 12, 2016, it resolved to submit a proposal of the Matters Concerning the Election of Accounting Auditors to the 80th Ordinary General Meeting of Shareholders to be held on June 29, 2016 as outlined below. This proposal is concerned with the change of its certified public accountant responsible for audit certification pursuant to Paragraphs 1 and 2, Article 193-2 of the Financial Instruments and Exchange Act. It should be noted that the proposal is based on a decision made by the Audit & Supervisory Board.
