INDICATIONS

TJ-501 is indicated for the relief of pain of a burn or hemorrhoids and for the healing of anal fissure.

DOSAGE AND ADMINISTRATION

Topical product

Clean the wound and apply an appropriate amount of TJ-501directly to the affected area, or dress the wound with gauze with an appropriate amount of TJ-501, several times a day.

PRECAUTIONS

1. Important Precautions

When TJ-501 is used, the patient's "SHO" (constitution/symptoms) should be taken into account. The patient's progress should be carefully monitored, and if no improvement in symptoms/findings is observed, continuous treatment should be avoided.

SHO: The term "SHO" refers to a particular pathological status of a patient evaluated by the Kampo diagnosis, and is patterned according to the patient's constitution, symptoms, etc. Kampo-preparations (Japanese traditional herbal medicines) should be used after confirmation that it is suitable for the identified "SHO" of the patient.

2. Adverse Reactions

TJ-501 has not been investigated (drug use investigations, etc.) to determine the incidence of adverse reactions. Therefore, the incidence of adverse reactions is not known.

When Shiunko was applied to mice with a third degree burn, regeneration of the epidermis was promoted¹⁾.

PRECAUTIONS FOR HANDLING

Caution should be exercised in handling TJ-501. If TJ-501 attaches to clothes, they are stained reddish violet, which is difficult to remove.
