INDICATIONS

Nourishment and revitalization in persons with following conditions:
Weak constitution, physical fatigue, weakness during and after illness, loss of appetite, pale complexion, and over-sensitive to cold.

If you take this medicine regularly for a long periods, consult a physician, pharmacist or registered distributor.

DOSAGE

Take the following dosages once a day.

Age	One dosage
15 years and over	1 bottle(30 mL)
Less than 15 years	Do not use

INGREDIENTS

Daily dosage (30ml) of this medicine contains the followings;

Ginseng Salsa Extrac	450 mg (equivalent to 3000 mg of the crude drug)
Cistanche Salsa Extrac	62.5 mg (equivalent to 250 mg of the crude drug)
Ginger Fluid Extrac	0.5 mL (equivalent to 500 mg of the crude drug)
Polygonati Rhizome fluid extract	0.24 mL (equivalent to 240 mg of the crude drug)
Lycium Chinense Fluid Extract	0.2 mL (equivalent to 200 mg of the crude drug)
Epimedii Herba fluid extract	0.1 mL (equivalent to 100 mg of the crude drug)

Inactive ingredients: JP Sodium Benzoate, JP Ethanol, JP Citric Acid Hydrate, JP Sodium Citrate Hydrate, JP purified water, JP Sucrose, JP D-Sorbitol Solution, JP Butyl Parahydroxybenzoate, Vanillin, Polyoxyethylene Hydrogenated Caster Oil 60, Polyoxyethylene(160) Polyoxypropylene(30) Glycol, dl-Mmalic acid, Flavor.

(containing 0.7 mL or less of ethanol)

PRECAUTIONS FOR STRAGE AND HANDLING

- (1) Store in a cool, dry place free from direct sunlight.
- (2) Keep all medication out of the reach of children.
- (3) Do not transfer this medicine to a different container (It may be misused or the quality may deteriorate).
- (4) Do not take this medicine after the expiration date.
- (5) Since this medicine contains crude drugs, precipitates or floating matter may appear. This does not however influence the efficacy of this drug. Take it after shaking the bottle well.
